The workshop addressed the gathering about Promoting Innovative Ventures: Role of Technology Business Incubator (TBI)– Overview

- 4. The resource person highlighted the Technology Readiness levels, company growth stages and Funding Sources.
- 5. The speaker had introduced the various funding schemes under BIRAC: BIG (BIOTECHNOLOGY IGNITION GRANT), SBIRI (SMALL BUSINESS INNOVATION RESEARCH INITIATIVE), BIPP (BIOTECHNOLOGY INDUSTRY PARTNERSHIP PROGRAMME), PACE(PROMOTING ACADEMIC RESEARCH CONVERSION TO ENTERPRISE) and SPARSH (SOCIAL INNOVATION PROGRAMME FOR PRODUCTS: AFFORDABLE & RELEVANT TO SOCIETAL HEALTH).
- 6. The resource person highlighted the innovations scheme for Disabled and Elderly people called Technology Interventions for Disabled and Elderly (TIDE) and announced that DST 'call for applications' for incubators is open for Startup India Funding Scheme from July 1st 2021.
- 7. <u>Feedback</u>: The students were moreover passionate to know how an innovative idea to be converted to a commercial business application, The session was concluded followed by a vote of thanks which was given by Mr. P.Balamurali Krishna, Asst. Professor –EEE.
