### 1. Policy Statement

This policy affirms our institution's commitment to maintaining a disabled accommodation to support the fundamental needs of physically challenged people.

### 2. Purpose

- To support the needs of disabled persons.
- To comply with the international instrument convention on rights of persons with disabilities, 2006.
- To align institutional practices with **UN SDG 10.6.10 – Reduced Inequalities (Disability accommodation policy)**.

### 3. Scope

This policy applies to:

- All disabled persons in the Institute.
- All **campus premises**, including academic buildings, hostels, canteens, parking, playgrounds, guest rooms, parks etc.

## 4. Definitions

**Disabled accommodation:** Also known as accessible accommodation, refers to spaces designed with features to accommodate individuals with disabilities, ensuring accessibility and comfort. These features can include wider doorways, roll-in showers, grab bars, and ramps, making it easier for people with mobility issues to access and use the space.

## 5. Policy Provisions

1. Elevators
2. Ramps
3. Barrier free (wheel chair accessible) toilets
4. Platform bridges
5. Special arrangements for differently abled students are made available in internet and multimedia resource lab.
6. Reserved seats available for disabled students at the library
7. Dedicated room made available for disabled students, where they can take rest when needed.
8. Two computers with speaker and microphone are reserved for disabled students to access the online resources and to prepare the documents.
9. Reserved parking (two/four wheelers) to minimize walking.
10. Provision for enquiry and information: Human assistance, reader, scribe, soft copies of reading materials, screen reading, etc.
11. Signage including tactile path lights, display boards and signposts.
12. **Inclusive Culture:** Creating a welcoming and supportive environment where individuals with disabilities feel valued and respected.
13. **Support Services:** Providing resources and support services to help individuals with disabilities participate fully in activities and programs.
