

NOW IT IS HERE BY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **Period of agreement:** This agreement will be effective from 21st May 2019 and shall be effective for 36 months. The parties to the agreement may extend the period after expiry of the term by mutual consent after executing a written document.
2. **Scope of work:** Scope of work shall be to identify, design and develop a novel solution for harvest and convert atmospheric humidity to potable water and in particular:
 - a. Identify appropriate technology solution which can harvest atmospheric humidity into water

- b. Research, develop and document the technology solution for harvest atmospheric humidity into water and the product shall be one single efficient and effective technology
- c. Identify appropriate technology solution to provide the right filtration to convert the harvested water into a potable water source.
- d. Transfer of technology related to research and development of the aforesaid product to Contrivation.
- e. Create a product solution based on the identified and developed technology which can be commercially viable and assist in commercialization of the developed technology.
- f. Provide guidance, advise and other requisite assistance in commercialization


3. **Role of Contrivation:** Following shall be the role of Contrivation:

- a. To define and provide detailed the requirement and specification for R&D activities and such other information and documents as may be required or sought by MITS
- b. To participate in all discussions related to research and development related to solutions
- c. To assist MITS in research and development effort
- d. To procure requisite equipments and consumables requisitioned by MITS and provide the same or source it and provide the same from time to time for the purpose of R&D. Contrivation may source equipment and consumables from MITS approved vendors if the availability, quality and pricing is acceptable. The equipments and consumables shall be provided by Contrivation to MITS within a reasonable time from the requisition.

4. **Role of MITS:** Following shall be the role of MITS

- a. To conduct the research and development activity as per the terms of this agreement
- b. To cause the research and development by deploying competent and experienced staff and obtain concurrence on the personnel to be deployed with Contrivation
- c. To adhere to the timeline as mentioned schedule 1 and quality requirement of Contrivation
- d. To assist in developing appropriate products for commercialization
- e. To assist in commercialization of the product
- f. To provide such other information and documents as may be required by Contrivation
- g. To provide a list of equipment's and consumables required for research and development work and may provide a list of recommended vendors for sourcing.
- h. Not to sub-contract or outsource the work under this agreement to any outside agency/entity.
- i. To provide reports on regular basis as may be mutually decided between the parties.

5. **Terms of payment:** Contrivation undertakes to pay the consideration over a period of time as mentioned in Schedule 1 on achievement of critical timeline and milestones specified thereto. Additionally, 5% of revenue generated from the products will be shared by Contrivation from the time of completion of this project for a period of 36 months. The payments shall be subject withholding taxes under the income-tax, if applicable. MITS shall invoice and issue appropriate receipts for receipt of consideration.


Additionally, MITS is also entitled for reimbursement of expenses such as travel, conveyance and stay expenses of its personnel as indicated in Schedule II. It is expressly understood that, the cost of equipment, consumables etc., provided by Contrivation to MITS shall not be part of the consideration.

6. **Ownership of equipments :** The ownership of the materials, equipments etc provided by Contrivation shall be with Contrivation.
7. **Confidentiality :** Following confidential clauses shall apply under this agreement and both the parties shall adhere to the confidentiality mentioned in this clause and parties may enter into a separate non-disclosure agreement based on the principles stated hereinbelow:
- a. Both MITS and Contrivation Labs acknowledge that certain Confidential information may be disclosed by one party to the other (the Party that owns and/or discloses the Confidential Information is hereinafter referred to as the "disclosing party" and the Party receiving or accessing such Confidential Information is referred to as "receiving party") during the tenure of this Agreement or performance of the respective obligations under the resultant definitive agreements hereunder.
- b. Confidential Information means all information identified as "Confidential", including but not limited to information concerning the trade secrets, intellectual property rights, know-how, formulae, processes, inventions, data, network configurations, system architecture, designs, flow charts, drawings, proprietary information, data or materials related to business, services, products, customers, employees, finances or operational information of either party, and any other confidential or proprietary information the disclosure of which might harm or destroy a competitive advantage of the disclosing party.
- c. The receiving party shall not, directly or indirectly, disclose to any third party other than its employees, affiliated companies, and authorized agents any information concerning the disclosing party's business methods, products, customers or finances, or any other Confidential Information which is disclosed to it by the disclosing party, without the prior written permission of the disclosing party, unless such



disclosure is specifically required in the course of the performance by the receiving party of its obligations hereunder or under the resultant definitive agreements. The obligations of receiving party under this clause shall not extend to any information which: (i) is or becomes a matter of public knowledge, not as a result of any action of the receiving party; (ii) is lawfully in the possession of the receiving party prior to a disclosure hereunder; (iii) is received from a third party who lawfully acquired such information without restriction, and without a breach hereof, by the receiving party; (iv) is disclosed by the receiving party with the disclosing party's prior written approval (v) the information is independently developed by the receiving party, without use of the disclosing party's Confidential Information; (vi) is disclosed by the receiving party under operation of law or regulation or legal process;

- d. The Parties acknowledge that this Agreement contains confidential information that shall be considered proprietary by both Parties, and agree to limit distribution of or disclosure about the Confidential Information hereunder and/or this Agreement to those persons who have the access to Confidential Information within their respective organizations with a legitimate need to know the contents of this Agreement. Neither party shall publicize or make any public announcement concerning the terms or nature of the relationship or this Agreement without the prior written consent of the other party.
- e. MITS and Contrivation Labs both acknowledge that any breach by them of their respective obligations under this Section may cause irreparable harm to the other party for which its remedies at law may be inadequate and that in the event of any such breach either party shall be entitled to seek equitable relief (including without limitation injunctive relief and specific performance) in addition to other remedies provided hereunder or available at law.
- f. The Confidentiality Obligations under this Section shall survive during the term of this Agreement and 3 years thereafter.
8. **Ownership of Intellectual property and usage:** The R&D has been commissioned by Contrivation and once the product completes research phase and ready for commercialization, all intellectual property in the research, product, invention and such other intellectual property in the work carried by MITS shall vest with Contrivation and MITS shall transfer all the literature, documents, information, technical know-how etc. to Contrivation immediately after receipt of all the payments under Schedule I.

Contrivation, allows for further continuation of development and research post completion of the current project. The outcome of the research shall be offered to Contrivation for commercialization first and in the event of refusal by Contrivation to adopt it may be offered to third parties on such terms and conditions as may be agreed in the separate agreement mentioned hereinabove. Contrivation should respond to the offer within reasonable time. In case Contrivation wants to take the new technology, same will be part of the new agreement agreed upon at that time.

MITS shall use the knowledge for educational purposes of its faculty and students and the same shall not be used outside MITS or the knowledge shall not be used for further commercialization.

Contrivation allows publication of technical and scientific articles by MITS based on the research under this agreement with specific written consent with Contrivation and such written articles shall be shared with Contrivation before obtaining consent of Contrivation.


9. **Rights of Contrivation:** It is agreed between the parties that, Contrivation shall be the owner of the technology and it shall be entitled to commercially exploit the technology and the products developed in terms of this agreement. Contrivation shall own the technology, Intellectual property, technical know-how, patents, copy rights, brands etc.

The right of the Contrivation shall include sale of technology during the force of this agreement or thereafter. In the event of sale of technology during the course of development or within 36 months from the completion of the project, Contrivation shall pay 20% of net sale proceeds (sale proceeds minus income-tax levy on Contrivation for sale) to MITS as part of consideration agreeing to transfer the technology during development stage subject to withholding tax under Income-tax law.


10. **Termination of agreement:** This agreement can be terminated in the event of following:

Whereas, **The Blend steel Engineering Private Limited, (BEPL)**, No:279, Women's SIDCO Industrial Estate, Kattur, Thirumullaivoyal, Chennai-62 industry is engaged in the manufacture of innovative products, research, design, development and consultancy in the field of material science and other related fields.

Both MITS and BEPL, now

1. Identifying the necessity of research and development in composite material as well as relating industrial training to science/ engineering/ technology students etc.
2. Recognizing the importance of a large group of highly skilled manpower in all fields related to composite materials.
3. To club their efforts by merging their resources and expertise.

PROPOSE to create a nucleus for encouraging high quality man power in the fields of engineering, sciences and technology with special emphasis on composite materials and their related fields etc.

Now, therefore, in consideration of interactive promises made herein and of valuable and good consideration, the receipt and sufficiency of both MITS and BEPL hereby acknowledge, and hereby agree to sign a memorandum of understanding (MOU).

ARTICLE-I: SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between MITS and BEPL for enhancing, within the country, the availability of highly qualified manpower in these areas, without any prejudice to prevailing rules and regulations in MITS and BEPL. In this regard any mechanism evolved and approved by the competent authorities under Govt. of India in so far as applies to MITS and BEPL. The areas of cooperation can be extended through mutual consent.

ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS

Both MITS and BEPL shall encourage interactions between the Engineers, Scientists, Research fellows, faculty members and students of both the organizations through the following arrangements:

- a) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- b) Organization of joint conferences and seminars;
- c) Practical training of MITS students at BEPL;
- d) Joint guidance of student projects/thesis and other areas of national interest at MITS and BEPL on mutually agreeable terms.
- e) BEPL would accommodate B.Tech. Students who have completed the 6th semester of their programme in such a number that BEPL deems convenient to it for the purpose of imparting industrial training.
- f) BEPL may seek assistance/guidance of MITS faculty member/s in product/process modification, modernization, trouble shooting, etc.
- g) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- h) BEPL may showcase its business activities at the seminar/workshop/conference, etc. at MITS.
- i) There will be no restriction on the content of the thesis and publication of thesis results, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent.
- j) Both MITS and BEPL will be free to independently carry out follow-up research on the thesis work conducted under this scheme.
- k) If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with the security of

the State and the Country, the same will not be allowed for publication/printing in any form whatever. If the outcome of a project results in an intellectual property, for which rights can be secured, it will be decided on case to a case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc by the parties under the law will be decided on case to a case basis after mutual consultation.

- l) Research supervisors from both the Institutes will be the corresponding authors in any publication resulting from the collaborative work. All the efforts put forth by the student/s as a part of this MoU will be accounted by way of reporting the work in thesis and/or paper publication, except the part for which IPR needs be claimed.
- m) Neither of the supervisors will publish the work carried out under this MoU without the knowledge of the other.
- n) In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

ARTICLE-III : SHARING OF FACILITIES

MITS and BEPL shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation.

ARTICLE-IV: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

- a) As per the discussion with Dr G Hemath Kumar, Research Professor, Department of Mechanical Engineering, Madanapalle Institute of Technology and Science, in Chittoor district, regarding the establishment and development of Composite Research Center (CRC) at MITS in order to carry out research work.
- b) The total fund of Rs/- 3,50,000.00 (three lakhs fifty thousand rupees) is allocated for the establishment and development of CRC unit in MITS. The BEPL will be paid the Rs/- 1,50,000.00 (Rupees one lakh fifty thousand) for the procurement of consumable items like polymer, fiber, hand tools and any other raw material involved during the process.
- c) The amount of Rs/- 25,000/- will be paid every first week of the month by the BEPL, and bill will be submitted before the last day of the month through proper channel of MITS.
- d) As per attachments of Annexure-I, the other support of equipment and place for establishment of research center, the MITS will be arranged

ARTICLE-V: EFFECTIVE DATE AND DURATION OF MOU

This MOU shall be effective from the date of its approval by competent authorities at both ends.

- a) The duration of the MOU shall be for a period of 2 years from the date of effective.

- b) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.
- c) Any clause or article of the MOU may be modified or amended by mutual agreement of MITS and BEPL.

ARTICLE-VI : IPR

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided mutually by the two parties.

ARTICLE-VII: CONFIDENTIALITY

- a) During the tenure of the MOU both MITS and BEPL will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any other purpose.
- b) Both MITS and BEPL shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any other use which is intended under this agreement or PROJECTS.
- c) Further both MITS and BEPL shall put in place adequate and reasonable measures to keep and store confidential information secure in order to avoid any unauthorized use.

ARTICLE-VIII : AMENDMENTS

Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.

ARTICLE-IX: MISCELLANEOUS

- a) The headings and sub-headings are inserted for convenience only and shall not affect the construction of this Agreement.
- b) During the term of this agreement, both MITS and BEPL is not directly or indirectly eligible to solicit or offer employment or engagement to any of the other party personnel without the prior consent in writing of that other party.
- c) No failure to exercise and no delay in exercising, on the part of a Party, and right, remedy, power or privilege hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right, remedy, power or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege. The rights, remedies, power and privileges herein

provided are cumulative and not exclusive of any right, remedies, powers and privileges provided by law.

(d) After this Agreement has been signed, all preceding understandings/negotiations and correspondence pertaining to it shall become null and void.



Description: The primary objective this project to upgrade the existed AIS system in the Indian Navy ships. The AIS data which can be transmitted in encrypted format and one can receive the AIS information with the decryption password under distress conditions during the war. The existed AIS system does not have such provision. Any commercial or civilians with a generic AIS receiver can able to receive the AIS data transmitted by the ship irrespective of its kind. This may lead to a security concern for the navy ships, as this may have exploited by the unauthorised personal.

The Automatic Identification System is an automatic tracking system used on ships and by vessel traffic services (VTS) for identification and location vessels by electronically exchanging data with other nearby ships, AIS base stations, and satellites. AIS information supplements marine radar, which continues to be the primary method of collision avoidance for water transport.

Information provided by AIS equipment, such as unique identification, position, course, and speed, can be displayed on a screen or an ECDIS. AIS is intended to assist a vessel's watch standing officers and allow maritime authorities to track and monitor vessel movements. AIS integrates a standardized VHF transceiver with a positioning system such as a GPS receiver, with other electronic navigation sensors, such as a gyrocompass or rate of turn indicator. Vessels fitted with AIS transceivers can be tracked by AIS base stations located along coast lines or, when out of range of terrestrial networks, through a growing number of satellites that are fitted with special AIS receivers which are capable of deconflicting a large number of signatures.

The Project was successfully demonstrated and undergoing various screening tests for the final submission of the project. An amount of **Rs: 1,50,000/-** (One Lakh Fifty Thousand Rupees only) grant was released by the funding agency after successful demonstration of the project. The Project shall be completed after the successful trial run of the design in real time operating conditions of the Indian Navy ship.
