This has reference to NBA's letter of even number dated 19-10-2022 under which Master of Computer Applications program offered by your Institution was granted accreditation for 2 years from the Academic Years 2022-23 to 2023-24 i.e., upto -30-06-2024 under January 2013 document by National Board of Accreditation.

2. National Board of Accreditation (NBA) has decided that in all cases where MCA Program of an Institution was granted accreditation for a period of 2 years, the period of accreditation of the program shall be extended from 2 to 3 years subject to the condition that the program meets the essential parameters of the Pre-Qualifiers. The Pre-qualifiers submitted by Madanapalle Institute of Technology & Science, P.B. NO-14, 10TH KM., Angallu, Kurabalakota (M), Madanapalle, Chittoor, Andhra Pradesh-517325 have been considered in NBA. The MCA program meets all the parameters of pre-qualifiers.
