BoS Members have approved the structure & syllabus for IV-year CST with the following suggestions/modifications.

- 1. The Course titled Perception & Computer Vision and Big Data Analytics were accepted by the members without changes.
- The members suggested to reduce the content from Unit III and IV in the Digital Forensics and further suggested include case studies in Unit V.
- 3. The members suggested to include the stability analysis in Unit II of Modelling and Simulation course.
- 4. The experts suggested to include the Case Studies and Modern Network Programming topic in the syllabus of Network Programming.
- 5. The members suggested to modify Unit I by removing the content related to filtering and include the same in Unit II.
- 6. The experts suggested to introduce the course Advanced Algorithms and Fundamental of Fog and Edge computing.
- 7. The members suggested to include the content related to Industrial Standards in the course on Human computer interaction.
- 8. The members accepted the course titled Sensors and Actuator Devices and Multi Agent Systems without changes.
- 9. In course titled Deep Learning Techniques the panel members suggested to include Case Studies in the Unit V.
- The newly included courses Quantum Computing and Augmented Reality and Virtual Reality were accepted by the members.
