The Head of the Department Dr. K.V.Geetha Devi gave welcome address. Dr.E.Gnana Prasuna introduced all Bos Members. Thereafter, faculty members introduced themselves. The Head of the department shared the contribution of faculty members and students and various events organized by the Department, during the last one year.

The Academic Coordinator Dr. K.Srinivasa Krishna gave presentation and elaborated proposed changes to the Regulation 2024 and detailed Syllabi of I year, I and II semester in R24 syllabus.

1. The Course Structure for MBA Program was discussed and accepted by all the BoS Members.
2. The detailed Syllabi of MBA 1st Year was discussed and accepted with minor changes in few subjects by the BoS Members.
3. A few of the courses in R22 regulation were redesigned and renamed as given below.
 - a. Two relevant courses combined together to offer it as a single course like Managerial economics & Business Environment in 1st semester
 - b. Information technology title has been modified as Data Analytics using excel in 1st semester
 - c. Business statistics for managers has to be renamed as Business statistics for managers using SPSS in first year. In R22 SPSS offered with BRM course
 - d. Personality development and Business communication courses are combined together and designed with title as Corporate Communication in 1st semester
 - e. Business Analytics introduced as a core functional subject in 2nd semester
 - f. Business research Methods using SPSS title which was there in R22 has been changed as Business Research & Econometrics.
 - g. MOOCS has been incorporated in R24 curriculum under open elective as a choice for the students.

In this meeting the following points were shared by External BoS Members:

1. For BRM course -Literature review can be taken from authenticated data base.

2. Personality Effectiveness as non-credit may be considered in third semester to groom for placements.
3. 2021-23 batch CO-PO attainment were presented in BOS meeting and the members are satisfied with the attainment.
4. The members have discussed and suggested a few new pedagogical methods in the teaching learning process which will be encouraged in the Department.

Members unanimously approve the course structure and detailed syllabi pertaining to I year MBA Program.

Members have appreciated the efforts made by the department in framing the R24 structure & syllabus.

The meeting concluded with the Vote of Thanks by Dr. V.G.Murugan , Assistant Professor, and ended up at 1.00 P.M.
