

Also, the Board has approved the Course structure & syllabi of fourth year B. Tech & second year MBA and MCA programmes as circulated vide mail dated 14th July 2023 (Annexure-IV).

Principal has informed the members that, MITS has completed 25 years of Academic Excellence and contributed to the economic & social wellbeing of the region. He also shared that, recently UGC has given Gazette notification No. CG-DL-E-02062023-246256, dated 2nd June 2023 inviting applications from institutions of Academic Excellence to become Deemed to be Universities.

In this context, our management deliberated at length and thought it would be a prudent decision to go for university status which will help MITS to expand its scope to serve the social motto of the academy in a larger way. Thereby, Ratakonda Ranga Reddy Educational Academy in its 45th meeting held on 8th June 2023 vide Agenda No. 04 passed a resolution and approved the proposal to convert 'Madanapalle Institute of Technology & Science' to Deemed to be University as per UGC Notification dated 2nd June 2023.

In this regard, the members of the BoG have unanimously approved the following items as per the Agenda 6:

- a. All the immovable Assets of MITS viz., College buildings & Land parcels to be transferred from MITS to the Proposed Deemed to be University (Annexure V Land Documents/Building Documents).
- b. All movable assets of MITS viz., Lab Equipment, IT Infrastructure, Furniture, Vehicles & Library Books/Magazines, etc., (Annexure VI List of Equipment, IT Infrastructure, Furniture, Vehicles, & Library Books/Magazines) to be transferred from MITS to the Proposed Deemed to be University.
- **c.** All liabilities with reference to movable and immovable assets to be transferred from MITS to the Proposed Deemed to be University.
- **d.** All law suits, legal issues, pending matters to be resolved or otherwise unresolved to be transferred from MITS to the Proposed Deemed to be University.
- e. All the Programmes (both UG & PG) being offered by MITS shall henceforth be offered by the Proposed Deemed to be University (Annexure VII List of Programmes).
- f. The Society will extend the Security Deposit of Rs. 25 Crores and also ensure financial & other necessary support for establishing the proposed Deemed to be University. The same has been approved and resolved in the 45th meeting of Ratakonda Ranga Reddy Educational Academy held on 8th June 2023.
- g. All Faculty members of all the departments including Non-Teaching staff members as well as all support staff will be transferred to the proposed Deemed to be University.
- h. All liabilities pending or otherwise, dues, benefits including post-retirement benefits of all employees, obligations if any, to be transferred from MITS to the Proposed Deemed to be University.

The members appreciated the decision taken by MITS to apply for Deemed to be University status which will definitely help the institute gain more autonomy & will be able offer more broad based education for the community around.

The members also congratulated the move and advised the Principal to maintain the quality in terms of Academics, Research, Innovation etc., in future too.

The members approved all the above agenda points i.e., from 6(a) to 6(h) through voicevote.
