

Principal brought to the notice of the members that as per the AICTE Approval Process Handbook, 2025, the application is opened, but it is not yet submitted as the information on the Deemed to be University Status is awaited.

However, the application shall be submitted to AICTE during the extension period after gaining clarity on the Deemed to be University Status.

He also sought the approval of the members for authorising him to take an appropriate decision on the Increase in Intake, Merger of the Courses, Closure of Courses, Reduction in Intake and Introduction of New Courses for the academic year 2025-26. The members have unanimously authorised Principal for taking appropriate decision as per the demand prevailing at the point of time of submission to AICTE.

# 7. Agenda Point 7: Ratification of the newly appointed Staff

Principal has shared with the members that the budget for the procurement of IT Infrastructure shall be placed for discussion during the next BoG Meeting, soon after gaining the clarity on Status of Deemed to be University.

## 10. Agenda Point 10: Principal's Report on Achievements

The members have appreciated the achievements of the Institute during the period.

Few of the members have given the following suggestions.

- Prof. M. Vijay Kumar suggested that the highest package of the Institute, related
  to placements is quite low and the concerned departments need to work on
  improving the same. To achieve this, he felt, meritorious students from 2<sup>nd</sup> year
  itself need to be identified and trained with the target of placing at least 6 -7
  students in the pay band of Rs. 15 lakhs and above.
- 2. Prof. NVR Naidu suggested that in each BoG Meeting, any one department may present the department's Vision, Mission, Achievements and Strategic Plan for 15-20 minutes to all the members. For which, Prof. M. Vijaya Kumar added that Principal may take the presentations of each and every department and encourage the best department to present the profile in the BoG meeting.

3. Prof. NVR Naidu further remarked that an NIRF Committee may be formed by identifying Criteria Coordinators for each Criteria who may initiate actions for improving the NIRF rankings significantly.
